## PARENTAL AND STUDENT REQUEST TO ATTEND

We, the parent(s)/guardian(s) of \_\_\_\_\_, request that he/she be permitted to attend Rock River School beginning the \_\_\_\_\_ school year. We understand that Rock River School is a small K-12 grade school located 40 miles north of Laramie. In order to have this unique schooling arrangement work, several ground rules have been established regarding student behavior, transportation, and activities.

Conduct required of students attending Rock River School is set forth in the student handbook. The student will receive a copy of the handbook at the time of the interview.

As parents/guardians, we agree that good student behavior must be exhibited by our student at all times when our student is transported on the bus, at school, or while attending school activities. We understand that a conference between our student's current principal and the Rock River School principal will be held to evaluate this request, and that either principal may deny the request. At this conference there will be a review of our student's academic record, behavioral record, and other school records. Decisions by the principal are final.

Students are admitted to Rock River School at the beginning of the school year. Occasionally, for rare and unusual circumstances, the principal may consider a transfer to Rock River School at semester change in January. The Rock River School principal may deny admission to a student based upon the student's discipline, attendance and academic record, or if the student's educational needs cannot be best served at Rock River School.

If a Laramie or Medicine Bow student incurs a disciplinary punishment that results in out-of-school suspension, the privilege of attending Rock River School may be forfeited. A student who is suspended for drugs, alcohol, or violent behavior may be returned immediately, following the completion of the suspension, to their home school.
